Processing

Depending on kind and intensity of the soiling, dilute OBTEGO® C-100 from 1:50 to 1:400 with water. The cleaner is moped manually or used in higher dilution with auto-scrubber machine. Take notice of OBTEGO cleaning recommendation!

Productiveness

Depending on soiling and surface, approx. 1.000 – 8.000m²/liter.

Storage

Shelf-life in cool and closed container is about 24 months.

All contained surfactants are biodegradable up to 98% (OECD method). The product is free of preservatives. WGK 1 (weakly water-polluting).
