
OBTEGO® C-200



Maintenance liquid for mineral surfaces

Description

OBTEGO® C-200 is a maintenance liquid with a perfectly balanced combination of different detergents, impregnation agents and waxes for already impregnated floors.

Properties

OBTEGO® C-200 dissolves and removes slightly impurities and is used for floor maintenance care. The maintenance liquid is used for manually application.

Application

For already impregnated, leached, mineral floors or surfaces. For the maintenance and refreshing of the gloss. Refresh also the protection of the surface.

Processing

Depending on the application use OBTEGO® C-200 undiluted up to a ratio 1: 100 with water. The product is applied by manual application with microfiber mop and polishing after drying. For polishing use single disc machine or auto-scrubber with suitable polishing pads or brushes.

Very dirty or dusty floors have to be pre-cleaned.

Productiveness

Depending on surface approx. $100 - 2.000 \text{ m}^2/\text{ liter.}$

Shelf life in dry and closed container, 24 months.
